- **The Geller Oncology Fund** was able to assist a family in need with food and school supplies for their two children when learning both parents were diagnosed and are being treated for cancer and are unable to work. Because of the continued generosity from you, we were able to assist this family with some of their needs.
- **The Hospice Fund** assists many individuals and families experiencing emotional and financial hardships. A Hospice patient with cancer had been without hot water for over 6 months. The patient and daughter were in need of a hot water tank but could not afford one. Through the Hospice Fund we were able to assist this family with the purchase of a new water heater and their friend was willing to install it. Having one less burden makes it easier for this patient to concentrate on recovery.
- ♥ The Linus Brennan Memorial **Fund** assists families who experience the loss of a child with burial fees and funeral costs. Recently, we had a stillborn birth at Lourdes Hospital and the family was unable to pay for the burial of their child. Because of this new fund, we were able to assist this family with this hardship.
- ♥ A patient with severe COPD, facing many financial hardships with limited funds found it very difficult to breathe during this humid, hot summer with many recurring visits to the hospital. Thanks to The Anderson Fund we were able to purchase an air-conditioner for this patient which improved the patient's breathing issues and reduced the number of visits to the hospital.




Mercy House of the Southern Tier

At the October Board Meeting, the Lourdes Foundation Board of Directors approved a donation of \$50,000 to The Mercy House of the Southern Tier to assist the organization in continuing their mission of providing end of life care to those patients who cannot be cared for at home. The Foundation previously made a gift of \$250,000 in July 2014 to assist in the startup costs of the facility. We are pleased to be able to provide support to this wonderful community organization.

The Mercy House of the Southern Tier provides a home-like environment that honors the dignity of the dying person. There are many needs of patients at the end of their lives - emotional, spiritual, social and physical – that are often not met in other care facilities. With Mercy House concentrating solely on end of life care, many individuals and their families are offered the space to find comfort and peace. We pray for the continued success of Mercy House.

Southern Tier Lyme Support, Inc.

In March 2016, the Board of Directors approved a request to assist the Southern Tier LYME Support Conference which was held in May. This conference brought together researchers, testing laboratories and treating clinicians to share with





and provide information to medical professionals, students and members of our community. The Foundation granted a gift of \$7,500 towards this effort. We are pleased to be able to support this vital community educational experience.

Hancock Volunteer Ambulance Corps

In March 2016, representatives from the Hancock Volunteer Ambulance Corps addressed the Foundation Board about their needs as an organization. The most important issue was the need to replace monitoring equipment in each of their ambulances. It is crucial, traveling from a town that is over 40 miles to the nearest hospital, that the medical personnel in the ambulance are equipped with the proper tools to provide life-saving measures if necessary.

The Foundation granted a gift of \$36,941.77 towards obtaining the necessary equipment. Often times, the ambulance is transporting a patient to Lourdes Hospital and we feel that this will directly benefit our patients and the community.

Donor Spotlight - Dr. John & Mrs. Linda Miller

Dr. John & Linda Miller have been members of the Lourdes family since 1993. Linda has held various positions in Lourdes beginning her career as a Nurse Educator and moving on to eventually holding her current position of Sr. Vice President of Operations/Chief Nursing Officer. Dr. Miller joined the Broome Urology practice in 1993 and has served patients at this office ever since. Both have been inspiring members of the Lourdes Hospital completed a Urology Residency in June, 1989, and was transferred community and continuously generous supporters of our work here at the Lourdes Foundation.

John W. Miller, MD grew up in Piscataway, New Jersey. He was the oldest of six children. His parents were Bernard and Mary Miller. Dr. Miller attended Fordham University and graduated with an undergraduate degree in Biology, and Georgetown Medical School. He was the recipient of a Health Professional Scholarship for medical school, and after completing medical school was assigned to Portsmouth Naval Hospital in Portsmouth, Virginia, to begin his surgical internship.

Linda Miller grew up in Tuxedo, New York. She was the youngest daughter of Pearl and Joseph McCormack. During Linda's senior year at Seton Hall, she made the decision to join the United States Navy after graduation. She attended Officer Indoctrination Training in Newport, Rhode Island, and then was assigned to Portsmouth Naval Hospital in Portsmouth, Virginia, as a Navy Nurse. Linda's first assignment as a new nurse was on a 36 bed medical unit at Portsmouth Naval Hospital.

Linda met Dr. Miller when he was a surgical intern covering the medical unit in December of 1981. They were engaged in April

1983 and married in August. They were blessed with their first child, John, in January, 1986. Linda transferred to the Active Reserves and returned to graduate school at Old Dominion University in Norfolk, Virginia. She graduated with a Master's Degree in Nursing with an education focus in June, 1989, the same month their second son, Matthew, was born. Dr. Miller to Oakland Naval Hospital in Oakland, California. Everything changed on August 7, 1990, when President Bush ordered the organization of Operation Desert Shield in response to Iraq's invasion of Kuwait on August 2nd. Dr. Miller was immediately deployed on the Hospital Ship Mercy. His deployment lasted eight months. During this same period when Dr. Miller was deployed, Linda was recalled to active duty and assigned to a surgical unit at Oakland Naval Hospital. Balancing the needs of the Navy and two small children was challenging. Evenutally Dr. Miller & Linda made the difficult decision to leave their Naval positions of Commander in the Medical Corps and Lieutenant Commander in the Nurse Corps respectively. Linda and Dr. Miller moved to Binghamton in the summer of 1992 and soon after, joined the Lourdes family.

We are so very thankful for Dr. John & Linda Miller's dedication not only to Lourdes Hospital but to our community members who are treated through both of their career efforts. They have been generous supporters of various programs and campaigns at the Lourdes Hospital Foundation and we are forever grateful to them as friends and benefactors. Thank you Dr. & Mrs. Miller!
