On a frequent basis the Lourdes Hospital Foundation receives requests to assist those in need with the basic necessities of life. Here are some of those individuals and their stories:

♥ **One of our patients here at Lourdes**, who was treated at Broome Oncology, was suffering from Stage IV Metastatic Cancer. Due to this reality, our patient who was the only wage earner in the household was forced to be at home thus eliminating any steady income. She was able to receive disability, but still found it difficult to make ends meet. **The Lourdes Foundation** was able to assist this patient with a gift card to be utilized in the purchase of groceries.

♥ **A cancer patient** who had been receiving chemotherapy here at Lourdes was also traveling to New York City to Sloan Kettering Hospital for additional treatment and eventual surgery. This individual had to make several trips there and was faced with mounting hotel and gasoline costs. Through the **Sock Out Cancer Fund** here at Lourdes our patient received the vital support to assist with these bills, which surely put this patient's mind at ease and aided in the healing process.

♥ **A patient at Broome Oncology** was recently treated for advanced Lymphoma. As a result of this illness he was unable to work, which effected his ability to pay bills, including a bill for an in-patient stay recently completed. Due to the financial hardships and challenges being faced our patient communicated to a nurse navigator that he was considering discontinuing his cancer treatment. Thankfully we were made aware of this situation and assistance in paying these bills was received through the **Geller Oncology Fund**.

♥ **A young Hospice patient** being cared for by her young adult children recently was assisted by the **Lourdes Foundation** in the payment of a recent NYSEG bill. In addition, this patient also received assistance in attaining the basic necessities of life.

These are but a few of countless people recently assisted as a result of your generosity in support of the Lourdes Hospital Foundation. On Friday the 12th of April, the Annual Sock Out Cancer benefit was held at Binghamton's Forum Theatre. A lively crowd gathered to hear an all-star concert of music from the 1980s performed by the renowned Phillip Meyers Band.

The featured artists that performed that night were Alex Ligertwood, the former lead singer for *Santana* and Kevin Chalfant, who has performed on stage as lead vocalist with *Journey*.

The show included classic songs from *Van Halen*, *Toto*, *Led Zeppelin*, *Joan Jett*, *Styx*, *Survivor*, *Boston* and *U2*.

Many cancer survivors, their families, as well as those currently receiving cancer treatment were in attendance. They very much enjoyed the performance and the opportunity to share in the joy and fellowship of that special evening.

The Sock Out Cancer initiative is the idea of Bruce Boyea, CEO and President of Security Mutual Life Insurance Company of New York. His dream of putting on an all-star show with proceeds being evenly divided between Binghamton's two health systems UHS and Lourdes has become a much-anticipated annual event.

After leaving the armed forces a career in marketing development and management blossomed. From field sales for the Maxwell division of General Foods to Export Manager to Development Manager to General Manager to Director, from Newark to Rye Brook to Brussels to Novi Sad to Anchorage to Vienna; Michael's managerial and financial skills and knowledge of the world at large developed. In the early 1980's he also returned to the world of higher education, studying both Marketing and Financial Management at

Columbia University. Presently Michael consults with the Dobransky Group Ltd., based in Vienna, Austria.

Upon his return to the USA, Michael has been very active in his church, St. John's Ukrainian Orthodox Church, both locally and nationally. He is also an active member of the German-American Club and the Ukrainian-American Veterans Post 43 in Johnson City, NY where he is presently serving as Commander.

Fr. Anthony Amato *in his own words...*

I was born in Greece, NY, a suburb to the west of the City of Rochester and I am the second of four boys in my family. We were educated at the Catholic school at our parish and then attended the Aquinas Institute of Rochester for high school. It was there, during my senior year, that I first considered the call to the priesthood. I did not pursue that call at first, but became a Computer Science major at the University of Rochester in the Fall of 2005. Rather quickly during that first year of college, I realized that I needed to explore my desire to think and write on topics in philosophy and religious studies. I switched to a double-major in those areas and during those years I had continued to develop a prayer-life. As I had entered my third year of college, I had decided that I wanted to pursue graduate studies in theology and become a college professor. As I graduated in May 2009, I began graduate studies at Boston College School of Theology and Ministry that Fall.

It was there, in Boston, living on my own for the first time, that I kept hearing a persistent call to look deeper

into the possibility of being a priest. I committed myself to praying the Liturgy of the Hours throughout the day and by the end of my first year of my Master's program, I began the conversation with the Diocese of Rochester to begin seminary when I graduate. Through a life of study and prayer, I was able to discern who God was calling me to be. I graduated in May 2011 and began the first year of seminary, in Rochester, that summer.

In August of 2012, the diocese sent me to study at Theological College at the Catholic University of America in Washington, DC. After four years of study, and one year full-time in a parish in my diocese, I earned a Licentiate in Sacred Theology and was ordained a priest on June 3, 2017. The bishop sent me to Tioga County, at St. Patrick Parish and Blessed Trinity Parish, as the parochial vicar. I have enjoyed my time in this part of the state and have made many friendships that will endure.

Lourdes Oral Health Initiative: Lourdes Oral Health Receives Delivery of a New Mobile Unit!



Lourdes Dental Services, consisting of Lourdes Centre for Oral Health and Lourdes Mobile Dental Services, advances our mission of providing quality, preventative and therapeutic oral health care to children and their families. Through collaboration, out-reach and education, Lourdes Dental Services increases public awareness of the importance of good oral health and its impact upon total health and well-being. Our Centre for Oral Health has been in existence since 2005 and continues to assist those most in need, especially children, with vital dental care.

An essential part of this undertaking is the mobile dental initiative, specifically the van itself, which goes out in the local community to assist those in urgent need of dental care, who are mostly children.

The current mobile unit was nearing the end of its life and therefore needed replacement. To that end, two local foundations heard our call for assistance and very generously granted us the much-needed funds for the replacement of our current mobile oral unit.

In the spring of 2018 the Dr. G. Clifford and Florence B. Decker Foundation made a commitment of \$401,566 that completely covered the purchase of a brand new mobile dental unit.

This new van will be used in out-reach to elementary schools as well as to rural and underserved communities in the Greater Binghamton area. Children will now have access to dental services such as our dental sealant program that has as its goal the preservation of first and second permanent molars from tooth decay by applying sealants to these young patient's teeth.

The Mee Foundation also made a commitment of \$50,000 which will fund the purchase of four Dexis Platinum Digital X-Ray Sensors that are utilized as part of this new unit.

These radiographic sensors will allow the dental clinician to take bite-wing and periapical images, which will then be used by the dentist to diagnose dental decay, abscesses, bone levels, missing teeth and developmental delays or abnormalities.

We expect delivery of this unit in July of 2019!

Big smiles will be seen from miles away and in the years to come as a result of the generosity of the Decker and Mee Foundation's generous support of this endeavor.
